SPEAKERS

J.R.Spencer is a Professor of Law at the University of Cambridge. His interests include criminal law, criminal evidence and comparative criminal procedure. His publications in this area include many articles, and (co-edited with Mireille Delmas-Marty) 'European Criminal Procedures' (Cambridge University Press, 2002). In 2000-01 he was a consultant to Lord Justice Auld's Review of the Criminal Courts. He is a QC (honoris causa), an Academic Bencher of the Inner Temple, and holds an Honorary Degree from the University of Poitiers.

Bertrand Favreau is a barrister established in Bordeaux since 1969 and in Paris, since 1993. Bâtonnier de l'Ordre [President of the Bar] des Avocats au barreau de Bordeaux 1984-1985. Chairman of the Human Rights Institute of the Bar of Bordeaux since 1985 Président fondateur of European Lawyers Union (UAE) (1986-1989) Currently: Chairman of the European Bar Human Rights Institute, (head office in Luxemburg).(IDHAE); Founding president of the International Human Rights Prize "Ludovic Trarieux" Publications:

William Robinson has for many years worked in the field of European law and language. After working as a legal translator at the European Court of Justice and then the European Patent Office, he returned to the Court of Justice in 1983 as reviser of translations of its judgments and other texts. From 1996 to 2009 he was a legal reviser in the European Commission's Legal Service in Brussels revising draft legislation and working on guidance and training for drafters. Since 2010 he has been engaged in independent research into EU legislative drafting issues and will take up a Sir William Dale Visiting Fellowship at the Institute of Advanced Legal Studies in London.

Jodie Blackstock is Senior Legal Officer (EU: Justice and Home Affairs) at JUSTICE. She holds responsibility for considering criminal justice initiatives within the EU and advising on their human rights implications. She was Called to the Bar of England and Wales in 2003 and prior to joining JUSTICE in January 2009, Jodie practiced from 1 Crown Office Row Chambers. She is the criminal and employed member of the European Committee of the Bar Council and a member of the European Criminal Bar Association. She is also an attorney-at-law in Trinidad and Tobago, and regularly assists on constitutional and public law matters as a door tenant at Freedom House Chambers, Trinidad, with appeals to the Privy Council in London. She sits on the executive committee of Amicus (assisting lawyers for justice on death row) with responsibility for casework on US death row cases.

Dr Simone White works for the European Anti-Fraud Office (OLAF) as a lawyer/policy officer attached to an investigation directorate carrying out work within the European institutions, in the EU Member States and in third countries. She is also an honorary researcher at the Institute of Advanced Legal Studies in London and publishes in the area of financial crime. She is a member of the Fraud Advisory Panel in the UK and of the European Criminal Law Association.
